



FIG. 1-Drain Current




FIG. 2-Body-Diode Forward Characteristics




FIG. 2-Normalized  $R_{\text{DS}(\text{ON})}\,\text{vs}\;T_{\text{J}}$ 




FIG. 4-Gate Charge Characteristics




FIG. 5-Safe Operation Area





FIG. 6 - Thermal Transient Impedance












FIG. 7 - Switching Time Waveform
