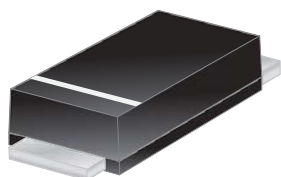

FIG. 1-Typical Forward Current Derating Curve

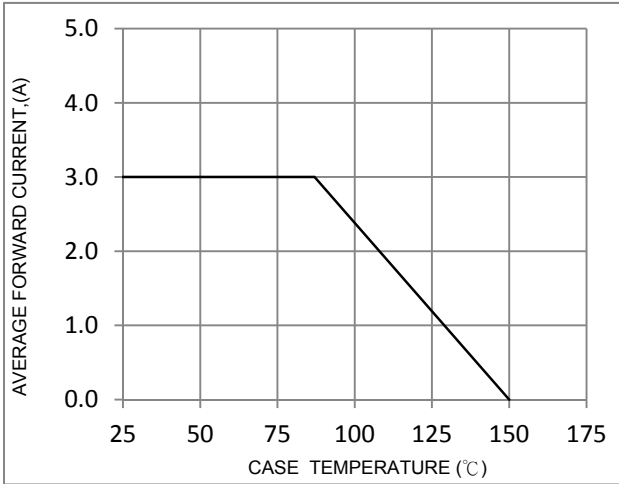


FIG. 2-Typical Forward Characteristics

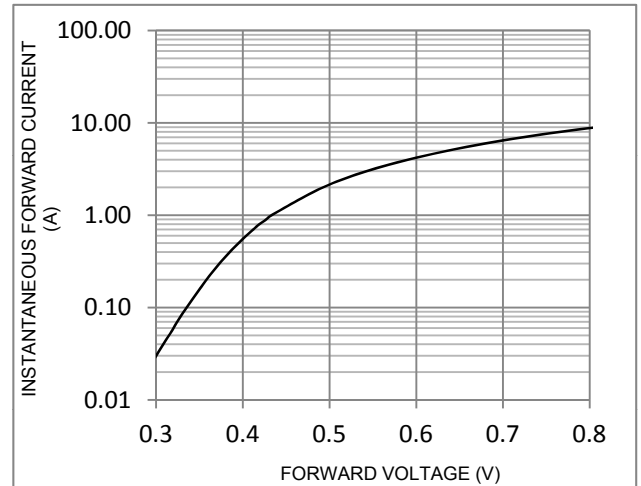


FIG. 3-Maximum Non-Repetitive Forward Surge Current

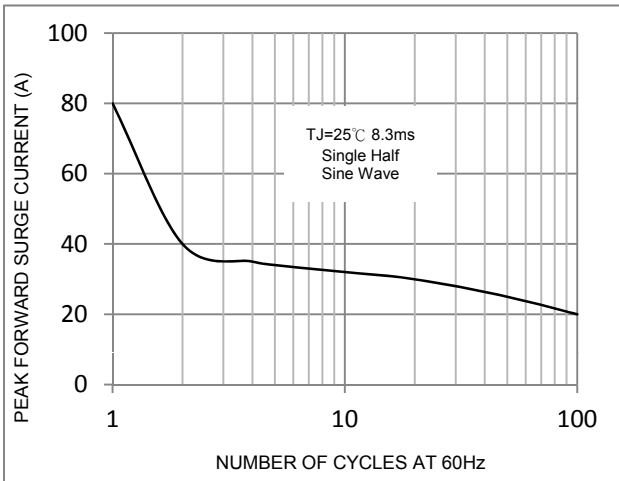


FIG. 4-Typical Reverse Characteristics

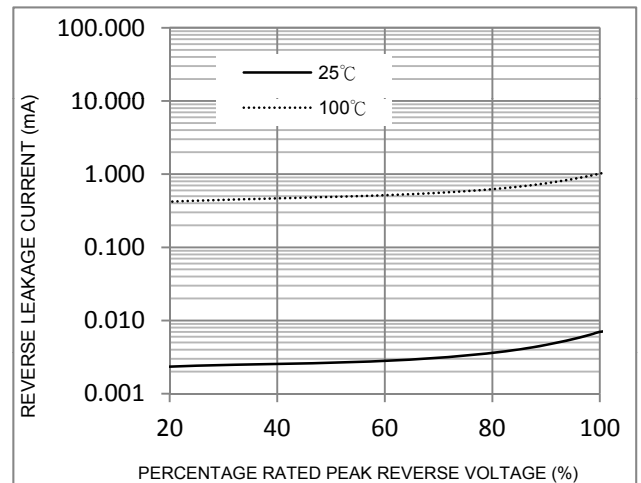
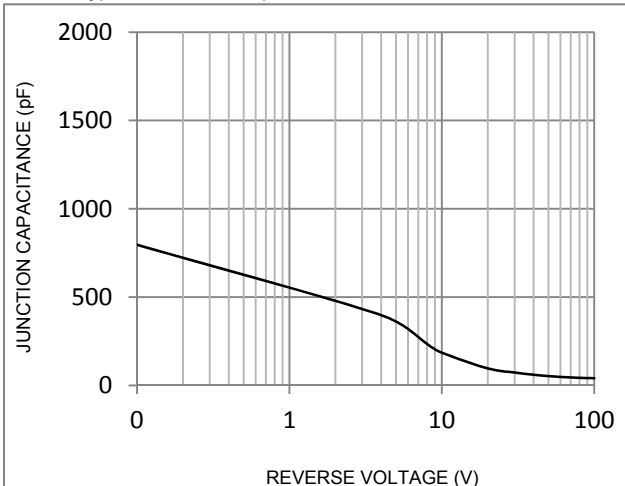
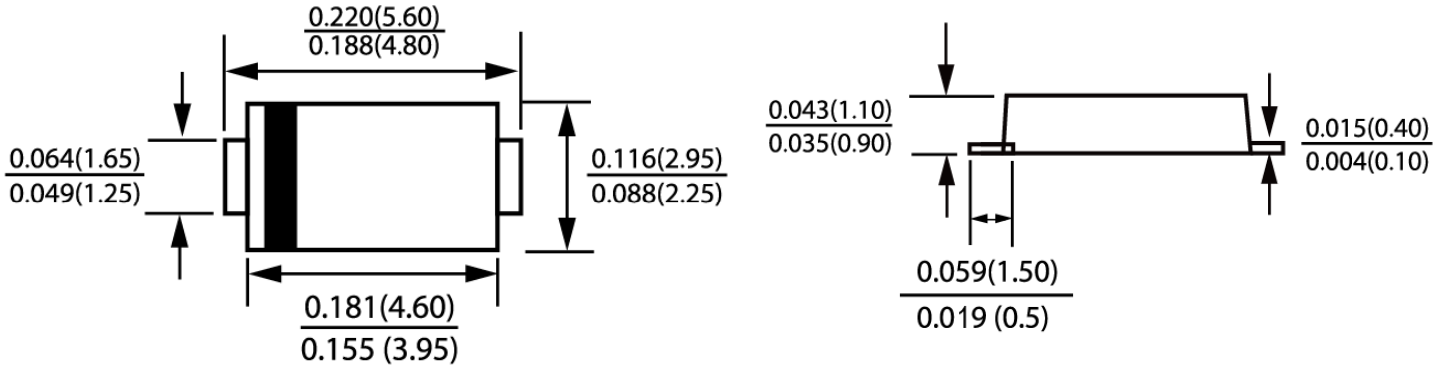


FIG. 5-Typical Junction Capacitance





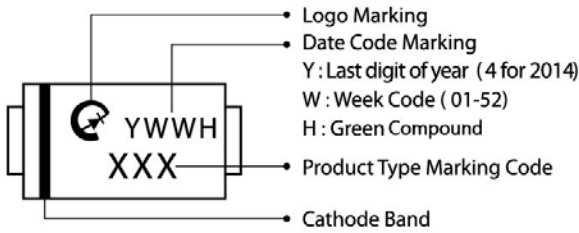

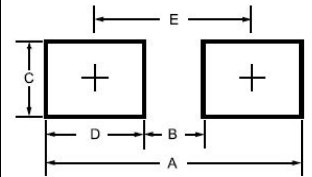

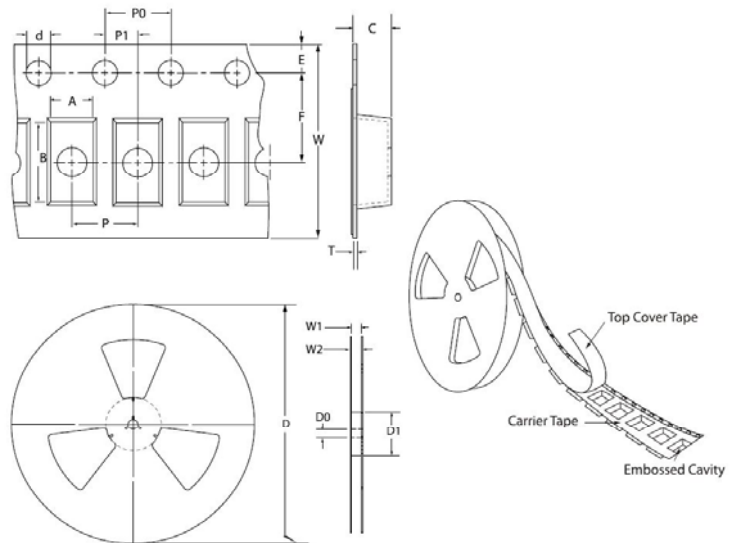
