




Fig.1 Continuous Drain Current vs. T<sub>c</sub>




Fig.3 Normalized V<sub>th</sub> vs. T<sub>J</sub>




Fig.5 Normalized Transient Impedance




Fig.2 Normalized RDSON vs. T<sub>J</sub>




Fig.4 Gate Charge Waveform




Fig.6 Maximum Safe Operation Area




Fig.7 Switching Time Waveform





Fig.8 EAS Waveform
