



FIG. 1-Transfer Characteristics






FIG. 3-R $_{\rm DS(on)}$ vs I $_{\rm D}$




FIG. 4-Normalized R_{DS(on)} vs T_J




FIG. 5-Gate Charge Characteristics





FIG. 6-Switching Time Waveform

FIG. 7-Normalized Maximum Transient Thermal Impedance




FIG. 8- Switching Time Waveform






FIG. 9- Gate Charge Waveform
